



## **Terms and Conditions - Apple Watch Prize Draw**

## **TERMS & CONDITIONS OF ENTRY**

### ***WHO CAN ENTER***

- Entry is open to NSW residents only, aged 13 years and older.

- Employees, affiliates, directors or officers of HMRI any companies or agencies associated with this raffle, and their immediate families, are ineligible to enter the draw. **Immediate families** means a spouse or former spouse, de facto partner or former de facto partner, child, stepchild, parent, step-parent, grandparent, grandchild, sibling, or step-sibling of an employee of HMRI.

## **HOW TO ENTER**

- HMRI's Health Pulse project will commence on 1 May 2025 at 10am (AEST) and conclude at 5pm (AEST) on 31 July 2025 ("**Promotion Period**").
- The raffle will open on 1 May 2025 and will close for participation on 31 July 2025.
- To enter the raffle, entrants must, during the Promotion Period:
  - complete HMRI's Health Pulse Survey; and
  - provide their contact details (first name, last name, valid email address and mobile phone number) in the section provided on the survey.
- No late entries will be accepted.
- Incomplete or incomprehensible entries will be ineligible to enter the draw.
- Entrants are strictly limited to one (1) entry only during the Promotion Period.
- HMRI reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity) and to determine any entrant or entry is ineligible if that entrant or entry is not in accordance with these terms and conditions or if an entrant tampers with the entry process. ## **PRIZE**

There is one (1) raffle prize available:

## **SECOND CHANCE DRAW**

  - does not respond within three (3) months of being notified that they have won the raffle, or
  - is not readily identified, and
  - reasonable efforts made by HMRI to identify the winner are unsuccessful, they will automatically forfeit the Prize and HMRI reserves the right to select another winner through a second chance draw.
